Family Accommodation Request for Transportation Guidelines

Student Transportation of Eastern Ontario (STEO) strives to ensure the safe transportation of students. Students are assigned one seat on one bus if they are deemed to be eligible riders. The "Family Accommodation Request for Transportation" form has been created for joint custody families. By completing the "Family Accommodation Request for Transportation" form and the "Parent Confirmation" form you are requesting eligibility for your child(ren) to ride on possibly two different buses.

For the safety of the student being transported the following guidelines must be adhered to:

- 1. School bus drivers are advised to only pick-up and drop off riders at authorized stops. Drivers cannot make changes to stops without authorization from STEO.
- 2. Students must be attending their home school.
- 3. Both transportation addresses must be within the home school boundary.
- 4. STEO must be provided with a clearly defined **consistent transportation schedule** at the time that the "Family Accommodation Request for Transportation" form is submitted.
- 5. Parents/guardians from both households must attach the written confirmation that they are aware of the transportation arrangements that have been requested. This must be addressed to STFO and dated.
- 6. Any changes to custodial arrangement concerning the transportation schedule require at a minimum two (2) weeks written notice and signed by both parents/guardians. This must be addressed to STEO and dated.
- 7. The "Family Accommodation Request for Transportation" package must be filled in completely, signed by both parents and the principal of the school.
- 8. To ensure the child's safety, STEO must have up-to-date and accurate information; therefore, the parents/guardians are required to re-submit the "Family Accommodation Request for Transportation" package annually as well as if either address changes during the current school year.
